Volunteer Agreement and Release from Liability

VOLUNTEER DRIVER and/or VOLUNTEER FOOD PREPARER:

- 1. LICENSE:** I have a current driver's license. If for any reason I do not have a current driver's license I will not volunteer as a Driver.
- 2. INSURANCE:** I have the minimum auto insurance required by the State of Oklahoma. If for any reason I do not have auto insurance I will not volunteer as a Driver.
- 3. COSTS:** I acknowledge that Edmond Mobile Meals, Inc. will not be responsible for any of the costs incurred by me when using my personal auto including, but not limited to fuel, maintenance, parking/speeding violations or any cost related to damage to my personal auto.
- 4. DUTIES:** I am aware that my duties as a driver may include, but are not limited to, delivering meals in my personal auto, or assisting meal delivery in the auto of another volunteer. I am aware that my duties as a kitchen volunteer may include, but are not limited to, heavy lifting, handling knives, operating heavy equipment, wrapping foods and cleaning up.
- 5. SAFETY CONCERNS:** I am aware that delivering and/or preparing meals is a potentially hazardous activity. Those hazards include, but are not limited to, injuries from slips and falls, back injury due to lifting or standing, burns or cuts, personal injury from car accidents, property damage or injury in accidents, falls, muggings and/or dog bites. I am voluntarily participating in these activities with the knowledge of the danger involved, and therefore agree to accept any and all risks of injury and will rely only upon my own insurance coverage.

VOLUNTEER OTHER:

- 1. DUTIES:** I am aware that my duties in/around the Edmond Mobile Meals facilities may include, but are not limited to, heavy lifting, cleaning, working on ladders, and carpentry work.
- 2. SAFETY CONCERNS:** I am aware that volunteering in/around the facility has a risk of physical injury. Those hazards include, but are not limited to, injuries from slips and falls, back injuries from lifting and standing, burns and cuts, and carpentry related injuries. I am voluntarily participating in these activities and therefore agree to accept any and all risks of injury and will rely only upon my own insurance coverage.

RELEASE: As consideration for being permitted to participate as a volunteer for Edmond Mobile Meals, Inc., I hereby agree that I, my assignees, heirs, spouses, guardians, and legal representatives will not sue Edmond Mobile Meals, Inc. or any of its agents, directors, employees, representatives, contractors, or volunteers on account of or in connection with any claims, causes of action, injuries, damages, costs or expenses without limitation, those based on the risks of death, bodily injury or property damage resulting from volunteer activities, the unavailability of emergency medical care; or, the negligent or deliberate acts of another person and including strict product liability or any other liability without fault.

PHOTO RELEASE: I acknowledge that my picture/likeness may be taken/recorded and release permission for that picture/likeness to be used by Edmond Mobile Meals, Inc. I acknowledge that Edmond Mobile Meals, Inc. may use said picture/likeness in print media or other forms of visual communication as it or its designees see fit. I agree that I am not entitled to any form of monetary/financial compensation for the use of my picture/likeness and have not been promised compensation.

I FURTHER CERTIFY THAT I, PERSONALLY AND AS A PARENT OR GUARDIAN, AM OF LAWFUL AGE, AND ARE LEGALLY COMPETENT TO SIGN THIS AGREEMENT; THAT I UNDERSTAND THAT THE TERMS HEREIN ARE CONTRACTUAL AND NOT A MERE RECITAL; THAT I HAVE SIGNED THIS AGREEMENT AS MY OWN FREE ACT AND IF I HAVE ANY DOUBTS CONCERNING THE CONTENTS OF THE AGREEMENT I WILL CONSULT AN ATTORNEY BEFORE SIGNING IT.
